# City of Lincoln Recreation SCHOLARSHIP APPLICATION FORM

*We recognize the important impact a summer program can have on young people, introducing them to a new sport, a new activity, a new past time. Because we want all children to have the positive experience our programs offer, the City of Lincoln Recreation Department offers scholarships for families who cannot afford the registration fees. We make every effort to provide enough support so that no child is denied participation in camp due to lack of funds.*

## GUIDELINES FOR SCHOLARSHIPS

1. All information relating to this request is confidential.
2. Programs have a limited number of scholarship monies available. Once a program reaches the maximum amount of scholarship monies available, scholarships will not be available for that program.
3. Scholarship applications must meet minimum criteria to be eligible.
4. Scholarship requests are processed on a first-come, first-serve basis.
5. Eligible participants may receive assistance for up to 50% of an eligible programs cost.
6. Scholarships are applied to registration fees only. Material fees, field trip fees, etc. must be paid for by the parent/guardian.
7. Each qualifying individual is eligible for up to \$200 in assistance per calendar year.

## **Eligibility**

- Scholarships are available to children 18 and under and who have not yet graduated from the 12<sup>th</sup> grade.
- The participant that the scholarship is being submitted for must reside within the Western Placer Unified School District in order to be awarded a scholarship to a City of Lincoln Recreation program.
- Each request is considered on an individual basis. Decisions are based on the child's needs and the availability of funds.
- Proof of current economic hardship must be included with each scholarship application. This may be in the form of a current 1040 tax form (first page), proof of unemployment, proof of eligibility for AFDC, food stamps, etc.
- All scholarships are supplementary. Families are asked to pay as much as they can toward the cost of recreation programs, thus enabling the scholarship funds to benefit as many children as possible.
- If the total household income is the same or less than the amounts on the income scale below, children in the family will be eligible for up to 50% discounts on selected programs offered by the Lincoln Recreation Department.
